

EDIBLE ITEM INDEMNIFICATION AGREEMENT

Baltimore Marriott Waterfront

IMPORTANT: This form must be submitted if you wish to distribute food/cake samples at the show. Exhibitors who plan to distribute food, cake, etc. **must** provide carpet or other floor covering in their booth and will be responsible for any cleaning costs associated with spills, stains, etc.

The Baltimore Marriott Waterfront will permit an exhibitor in the Baltimore Bridal Show to distribute food and/or cake samples only if such the exhibitor acknowledges, by its signature below, its agreement to accept the responsibility and abide by the terms set forth in this agreement.

1. Exhibitor agrees that any edible item distributed at the event shall be sample sized (2oz or less) and must be provided at no charge.
2. Exhibitor agrees to use proper food preparation, handling and storage methods in accordance with standards set forth by any applicable government agency.
3. Exhibitor may not use any Hotel kitchen facilities to store or prepare food.
4. Exhibitor must provide carpet or other floor covering in their booth and will be responsible for any cleaning costs associated with spills, stains, etc.
5. Exhibitor agrees to waive any claim for damages of any nature and release Showcase Productions, Inc., any show sponsor, the Hotel, its owner, Marriott International, Inc., its subsidiaries, affiliates, officers, employees and agents from any liability or responsibility whatsoever for any ill effect, injury, or loss incurred by the exhibitor or any third party including all manner of actions, causes of action, suits, debts, damages or claims and demands of any type or kind whatsoever, occurring from, connected with, or originating from Exhibitor's distribution of food at the Baltimore Bridal Show.
6. Exhibitor agrees to indemnify, defend and hold harmless Showcase Productions, Inc., any show sponsor, the Hotel, its owner, Marriott International, Inc., its subsidiaries, affiliates, officers, employees and agents from and against all liability, claims, suits, demands, damages, judgments, costs and expenses to which any of the above-named parties may be subject by reason of any claim for, any injury to, or death of any person or persons, or for damages to property or otherwise arising from or in connection with Exhibitor's preparation or service of food at the Hotel.
7. Exhibitor's signature below indicates that Exhibitor has read and understood this agreement and agrees to its contents. Exhibitor also acknowledges that the person signing on behalf of Exhibitor is authorized to bind Exhibitor to the terms of this agreement.
